According to Corporations Act 2001 Section 201A, a proprietary company must have at least 1 director. That director must ordinarily reside in Australia.

Corporations Law permits a sole Director company to not have a Company Secretary. However, Section127 of the Corporation Act requires that when a sole Director executes a legal document without a common seal; the sole Director of the Company must also be a Company Secretary of the Company. There are no major disadvantages in the sole Director to also act as Company Secretary and our Solicitors recommend that the sole Director should also act as Company Secretary of the Company.
